

Privacy policy

An 't Noordende respects its customers' privacy, in particular their rights with regard to the automised processing of personal information. In order to be fully transparent, we have formulated a policy and implemented it with regard to that processing of personal information, so those involved can assert their rights as well as possible. The privacy policy made available to you is the only version of it that applies, until a newer version replaces the present version.

Article 1 - Legal provisions

The following is responsible for the processing of personal information (hereinafter also called: "the administrator"): An 't Noordende, registered at Lhee 10, 7991 PE Dwingeloo, Chamber of Commerce registration number: 04064605

Article 2 - Processing of personal information

- Your personal information will be collected by An 't Noordende. Personal information includes: all information about an identified or identifiable natural person who can be identified directly or indirectly, namely via the use of an identifier, for example a name, an identification number, location information, an online identifier or one or more elements characteristic of the physical, physiological, genetic, psychological, economic, cultural or social identity.
- 2. We process the following categories of your personal information:
 - a Name
 - b Sex
 - c Address information
 - d Email address(es)/telephone number(s)
 - e Bank account number(s)
 - f Date of birth/age
 - g Place of birth

Article 3 – Purpose of processing personal information

We do not collect your personal information for no reason. Your personal information is processed to:

- Provide you with better service.
- Maintain relations with you.





- Inform you about changes to our services and products.
- Be able to call or email you if necessary to be able to carry out our services.
- Deal with your payment.

Article 4 – Registration of personal information

Your personal information will be recorded in an (electronic) register.

Article 5 – Your rights with regard to your personal information

- 1. Pursuant to article 13(2), point (b) the General Data Protection Regulation (GDPR), everyone has the lawful right to inspect, correct or delete his or her personal information, or restrict the processing of his or her personal information, as well as the lawful right to object to the processing of his or her personal information and the lawful right to data portability. You can assert those rights by contacting us via info@antnoordende.nl.
- 2. To every request to do any of the above, a copy of a valid ID card should be added, with your signature on the copy and the address where you can be contacted. Within 1 month of submitting the request, you will receive an answer to it. Depending on the complexity of the request(s) and the number of requests, this term can be prolonged with 2 monthsif necessary.

Article 6 - Legal obligations

In the case of a violation of any legislation or regulation, of which the person involved is suspected and for which the authorities need the personal information collected by the administrator, personal information will be given to the authorities after an explicit and justified request of those authorities, after which that personal information consequently will not be under the protection of the regulations of this privacy policy anymore.

Article 7 – Commercial offers

- 2. Your personal information will not be used for commercial purposes by partners of the person responsible.





Article 8 – Data retention period

The personal information collected by the administrator will be used and retained for a time period regulated by law.

Article 9 - Applicable law

Dutch law applies to those conditions. The court of law of the location of the administrator's registered office has exclusive jurisdiction when it comes to any disputes about those conditions, save when a lawful exception is applicable.
